Information on the processing of personal data

Data controller

Legal basis and purposes of processing

The processing of data carried out by G-Squared is necessary for the execution of pre-contractual measures (Art. 6(b) of the GDPR) related to personnel selection processes that originated from the receipt of your resume. Your personal data is processed for the purpose of evaluating your application, conducting a possible interview, and any other activity that may be necessary for the performance of personnel selection operations.

Communication of data to third parties

Duration of processing

The data collected in relation to the aforementioned purpose will be kept for the time necessary for the purposes indicated and in any case for a period not exceeding two years.

Category of data processed

The data processed are the candidate's personal identification and contact details (name, surname, place and date of birth, tax code, telephone number, email address, educational qualifications) and, in any case, all the data contained in the Curriculum Vitae sent to G-Squared s.r.l.

Mandatory nature of data processing

The processing of your personal data is necessary to pursue the purposes indicated above. Failure to provide such data will prevent the personnel selection process from being initiated.
