Type of data processed

G-Squared via email messages, this involves the acquisition of the aforementioned email address, as well as the sender's first and last name. The purpose is to respond to requests received by the Data Controller.

Purpose and legal basis of data processing

The legal basis that legitimises G-Squared to process the IP address is G-Squared's legitimate interest in having an institutional web platform. The purpose of processing the IP address is to enable the normal functioning of the website. Furthermore, the optional sending of messages by the sender through the G-Squared website implies the acquisition of such data in order to respond to the aforementioned requests.

Recipients of the data

The personal data collected is processed by G-Squared staff, who act on the basis of specific instructions provided by the Data Controller. The data may be disclosed to parties identified as Data Processors, who will process it by virtue of their specific appointment. The data may be disclosed to specific parties in compliance with legal provisions, regulations or EU legislation and within the limits of these. The data is not disclosed.

Scope of data circulation and transfer of data outside the EU

For administrative purposes, we inform you that your data may be communicated by the Data Controller to external collaborators for processing (e.g. accounting firms) limited to the fulfilment of your requests. Furthermore, the data may be transferred to countries outside the European Union, but the Data Controller guarantees that the foreign entities adhere to the Data Privacy Framework adopted by the EU Commission on 10/07/2023 and are therefore included in the "Data Privacy Framework List" maintained by the United States Department of Commerce.

Methods of data processing

Personal data is processed by personnel designated as data processors using automated tools for the time strictly necessary for the purpose.

Links to/from third-party websites

From this website, it is possible to connect to other websites via specific links, or it is possible to connect to our website from third-party websites. The Data Controller declines all responsibility for any request and/or release of personal data to third-party websites.

Data retention

We inform you that data relating to browsing logs, if recorded, will be stored by the Data Controller for a period of 6 months. Data provided by sending e-mails or filling in contact forms on the website will be stored for the

Time necessary to provide a response. We also inform you that the data you provide for contractual purposes will be processed for the entire duration of the existing relationship and further stored exclusively for the period required to fulfil legal obligations, unless it is necessary to store them further to defend or assert a right or to fulfil any additional legal obligations or orders from the Authorities.

After the expiry of the retention periods according to the criteria indicated, the Data Controller will take measures to delete or anonymise data that does not need to be retained for specific regulatory obligations.

Rights of data subjects

Data subjects have the right to obtain from G-Squared, in the cases provided for and as applicable, access to their personal data and the rectification or erasure of such data or the restriction of processing concerning them or to object to the processing (Articles 15 et seq. of the Regulation).

Data subjects who believe that the processing of their personal data through this website is in violation of the provisions of the Regulation have the right to lodge a complaint with the Data Protection Authority, as provided for in Article 77 of the Regulation, or to take appropriate legal action (Article 79 of the Regulation).
